**Charlotte Heart Recipient Raises Awareness of the Need for More Minority Organ and Tissue Donors**

Bobby Height, Sr. had been a healthy, athletic person all of his life. He competed on the basketball court and baseball field in college and high school, was drafted by the New York Yankees and played outfield until a knee injury cut his career short. He never imagined that one day he would need a heart transplant.

"One morning in 2003, I became dizzy and I passed out. The medics took me to the hospital where I was later diagnosed with cardiomyopathy, which is simply an unhealthy heart. For years I was treated by doctors. Suddenly in 2007, I became extremely fatigued and suffered shortness of breath," Height said. He was quickly put on the waiting list. Waiting for only 33 days, Height received a heart transplant at Carolinas Medical Center.

In an effort to increase the number of people who sign-up as organ donors, Height shares his story through community presentations on behalf of LifeShare Of the Carolinas and Donate Life North Carolina. Just in time for National Minority Donor Awareness Day (NMDAD), Height's testimony is one of several "Stories of Hope" featuring people of color on the Donate Life North Carolina website.

Minority individuals, like Height, have become the majority in North Carolina for those on the national organ transplant waiting list. Out of 3,600 individuals in need of various types of organ transplants, more than 2,000 identify themselves as an ethnic minority. Ninety-five percent are in need of a new kidney. Of the roughly 3,100 individuals in North Carolina listed for a kidney transplant, 1,802 are African-American, 82 are Hispanic, 64 are Asian and 32 and Native American/Pacific Islanders. African-Americans and Hispanics are four times more likely than Caucasians to be on dialysis because of kidney failure. The deciding factor on who can donate an organ and who can receive one is based upon strict medical criteria. Race, income and religion are not considered.

Prevention is a key component of NMDAD. To reduce the need for transplants, people are urged to live healthier lifestyles by getting daily exercise, eating better, getting annual physicals and having their blood pressure checked on a regular basis. "Health disparities in minority communities have contributed to similar disparities on the transplant waiting list," according to Sharon Hirsch, Executive Director of Donate Life NC. "One way we can address this critical gap is to encourage more people to register as organ, eye and tissue donors. One person can save up to eight lives and enhance the quality of life of up to 50 more."

State residents can register to be organ donors when they visit the NC Division of Motor Vehicles by requesting a heart be placed on their driver's license or state-issued identification card. Additionally, individuals can register online by visiting [DonateLifeNC.org](http://DonateLifeNC.org) or by sharing their decision to donate on their Facebook Timeline.

"I am alive today because someone said 'yes' to the generous gift of donating life so that I might have a second chance in fulfilling my life's purpose," Height said. "Because of me and my story, people are making the choice to become organ donors. If you haven't already done so, sign up today."
