## NC Small Grain Grower Association Assessment Referendum Vote

The North Carolina Small Grain Growers Association (NCSGGA) has announced that an Assessment Referendum will take place on August 7. Polling places will be located throughout the state in each county extension office. This assessment is for a six year period on all small grain (wheat, rye, oats, barley, rape seed/canola and grain sorghum).

The North Carolina Board of Agriculture approved the request for this referendum at their meeting in Raleigh on February 26. The assessment will be 1/2 of 1 % on wheat, rye, oats, barley, rape seed/canola and grain sorghum for a six year period. This assessment period will begin on January 1, 2014, and will continue until December 31, 2019.

Clifton Paul, Grantsboro, NC, NCSGGA President, said, "This assessment is important to the small grain growers of North Carolina to continue the work of the association in Grower Education, Research, Marketing, Administration and enhancing ways to grow small grain more profitable for farmers in North Carolina."

All North Carolina Farmers who grow small grain over the age of 18, as of August 7, 2013 are eligible to vote during regular business hours of their local county office of the North Carolina Cooperative Extension Service. The Anson County Cooperative Extension Office is located at 501 McLaurin Street in Wadesboro. Office hours are 8:30 a.m. to 5 p.m.

## FSA Reminder to Report Late Planted Soybeans

Soybean growers who reported that they had soybeans that had not been planted by July 15th but that they intended to plant during the late planting period, from June 30 to July 25, are reminded to notify the county office within 15 days of planting the beans. All information required for timely planted beans will be required for the late planted beans.

Anita Solesbee, County Executive Director, said, "We will need the farm number, tract number and field number where the beans are planted, the acreage planted, and the date of planting. We will be glad to forward the planted acreage information to the applicable crop insurance agent as required if written permission to share this information has been furnished to the Anson County Farm Service Agency.
