This is a release from the Wadesboro Police Department: On Friday, July 26 the Wadesboro Police Department

located an unidentified body on the roadside of Highway 52 South near Old Lilesville Road. Investigators believed individual was struck by a vehicle and therefore turned the investigation over to the North Carolina State Highway Patrol.

Wadesboro The Department was notified by the North Carolina State Highway Patrol that the body found was that of Anthony Valladares, a 17 year old who was previously reported as missing on July 23, 2024.

Statement from Agriculture Commissioner on Waiving of Motor Vehicle Regulations to Help Farmers

Agriculture Commissioner Steve Troxler released the following statement regarding Gov. Roy Cooper's issuance of Executive Order 311 in preparation for the remnants of Hurricane Debby moving into North Carolina:

"North Carolina's farm community is no stranger to dealing with hurricanes and tropical storms bearing heavy rain and know what needs to be done ahead of the storm to help limit damage. The waiving of some motor vehicle regulations related to agriculture is a big help to farmers readying their farms for bad weather.

"At my recommendation and as allowed by state law, the Governor has directed the Department of Public Safety to temporarily suspend weighing vehicles used to transport livestock, poultry, feed and crops in the state.

'This Executive Order will allow our farmers the opportunity to harvest as much of their crops as they can before the storm hits and will help ensure that livestock, poultry, crops and feed can be moved as needed. The order also temporarily suspends the maximum hours of service for drivers.

"I urge farmers to take this storm seriously and do what you can now to be prepared. Check your generators, fuel and emergency kits. We don't know what impact this storm will have yet on our state. But we do know that preparation saves lives and protects property.

Wildlife Commission Announces 2024 Flounder Season

The N.C. Wildlife Resources Commission (NCWRC) approved a temporary amendment to the flounder rule at their business meeting on July 25th that was subsequently approved by the N.C. Rules Review Commission (RRC) on July 31st. Under this modification, the 2024 flounder season will be open in

Inland Fishing Waters and in Joint Fishing Waters for hook and line fishing only on September 1st and 2nd and again on September 7th and 8th. The daily creel limit is one fish with a minimum size limit of 15-inches. With the approval of the NCWRC and

RRC, there will be a lawful recreational flounder season in both inland fishing waters and joint fishing waters for hook and line only," according to NCWRC Executive Director Cameron Ingram.

The designations for inland and joint fishing waters can be found online using the agency's fishing access area map (ncpaws.org/ncwrcmaps/FishingAreas) and zooming in on the Coastal Region where inland waters are shown with no color, joint waters are outlined in red, and coastal waters are outlined in blue. In Anson County there are several waters, including the City Pond, Little Park, Pee Dee Wildlife Refuge, Plank Road at Rocky River and the Pee Dee River at Highway 74. Wildlife Commission fisheries biologists will be conducting a flounder harvest creel

survey during the open season dates at many boating access areas," said NCWRC Assistant Chief of Inland Fisheries Corey Oakley. "We look forward to speaking with anglers to better understand fishing effort and flounder harvest during the shortened season."

The N.C. Division of Marine Fisheries (NCDMF) has stated they will not open the recreational flounder harvest season in 2024 due to the recreational sector exceeding the 2023 harvest allotment last year. Initially, the NCWRC proposed a temporary rule to close the flounder harvest season in 2024 in its jurisdiction, all Inland Fishing Waters and hook and line fishing in Joint Fishing Waters, to remain consistent with the NCDMF. However, after reviewing and considering the available data and public comments, the NCWRC adopted amendments to provide a limited 2024 flounder season that balances the needs of the resource and the public.

The harvest allotment for flounder, as set by the N.C. Marine Fisheries Commission (NCMFC), is currently split 70 percent to the commercial sector and 30 percent to the recreational sector. The split is scheduled to transition to 50 percent for each sector by 2026. The NCWRC in a letter from Chairman Monty Crump requested the NCMFC to accelerate the transition to a 50 percent split for 2024 and allow a recreational season coastwide. The four-day season approved by the NCWRC was calculated to allow recreational anglers an opportunity to harvest fish without exceeding the allotment, if the allocation was shifted as requested.

Not only are children who attended Pre-K more successful in school, they usually have

higher grade point averages and are more likely to graduate high school and college. NC Pre-K classes operate on a regular school calendar and are designed to address

emotional and social development, physical health, language development, and cognitive functioning. Through the incorporation of indoor and outdoor learning environments, students participate in active learning experiences to foster a lifetime love of learning. A high priority is placed on serving children who meet the following criteria: child's family is at or below 75% of the state median income level, a disability has been identified,

limited English proficiency, developmental differences, chronic health conditions, or a parent who is active military service personnel. There are currently four centers operating NC Pre-K classes in Anson County. These
