

To be seen for services at Anson County Health Department Clinic

Effective February 1, 2015, Anson County Health Department no longer accepts a client's declaration for income verification. All programs and services which require the application of the "sliding fee scale" for services received must have documentation of household members and income for all household members before qualification for the sliding fee scale can be completed.

Clients will not be denied services if they do not have documentation on date of service. However, they will be charged at 100% and given 15 days from date of service to provide documentation. Failure to provide documentation in the allotted time will result in 100% charges standing for provided services.

Who is Required to Bring in Documentation:

- Clients with insurance that is accepted by Anson County Health Department must provide financial documentation for sliding fee scale to be applied to copayments and amounts applied to deductible of insurance.
- Clients who have insurance but is not accepted by Anson County Health Department. These clients will be treated as a self pay client.
- Self Pay - Clients who have no form of insurance and request services in which the sliding fee scale must be applied.

Exceptions:

- Clients for services who have active Medicaid which will cover the services provided.
- Clients who chose to waive providing documentation and be charged at 100% for all applicable services.
- Clients who request "flat fee" services, i.e. TB Skin Test, Immunizations, certain procedures, will not be required to provide documentation as the sliding fee does not apply to these services.
- Clients who request services in which the sliding fee does not apply, i.e. std clinic and communicable disease.

Anson Crisis Ministry, Feed My Lambs, Both Helping Those in Need

If you or someone you know is in need of assistance due to financial difficulties, Anson County has places and people who care and are willing to help. With that help comes stipulations, but if the need is there you should by all means check them out.

Anson Crisis Ministry, located on Rutherford Street in Wadesboro, is open on Monday, Tuesday, Wednesday and Friday. The hours of operation are from 10 a.m. until 1:30 p.m. for food, and 10 a.m. until 2:30 p.m. for the store. "We serve relatively low income and needy families," said volunteer Margot Barnes. "In order to receive benefits you should bring with you your social security card, and the cards of family members. Also bring a proof of residence in Anson County such as a piece of mail with your mailing address printed on it, a rent receipt, etc. A government letter or disabilities check stub could provide proof of income. If you receive food stamps you can bring in the readout from the Department of Social Services showing how much you receive in food stamps per month.

Anson Crisis Ministry's main focus right now is food, but they also have clothing, household items, and at times, furniture and appliances, depending on what has been donated. Because there are so many new clients at this time, they are unable to offer help with utility payments, but can offer clothing vouchers twice per year.

Located on Highway 74 West of Wadesboro is Feed My Lambs. They too have clothing, household goods and other donated items at very forgiving prices for needy families. Their office and store hours are Tuesday, Thursday and Friday, from 10 a.m. until 5 p.m. The food office is closed from 11:30 until 1:30 p.m. for lunch. The store located inside Feed My Lambs is open on the first Saturday of each month, from 10 a.m. until 2 p.m.

Free Parenting Classes, Diapers, Ultrasounds & Pregnancy Tests

Learn about parenting in a small group setting while earning free diapers. Free parenting classes are offered by HOPE Pregnancy Resource Center at 3 p.m. on Tuesdays. They take place at the HOPE Office located at 19 South Williams Street in Polkton. Attendees earn a pack of diapers for every two classes they participate in. To sign up call 704-690-6689.

HOPE brings their mobile ultrasound unit to the Wal-Mart shopping center in Wadesboro on the third Thursday of each month, from 2 until 5 p.m. for free pregnancy tests and ultrasounds.

They also have an ultrasound machine at their office and set up ultrasounds on the first Monday of each month. They can give pregnancy tests in the office as well. It is always best to schedule the tests and ultrasounds, but they do try to accommodate walk-ins when possible.
