

Wadesboro Author Releases 10th Book

"When He Said Goodbye" is the latest book authored by Sandra Bruney of Wadesboro. A work of Christian fiction, the novel tells the story of a woman whose husband disappeared on her 40th birthday. She is the only one who doesn't think he left her and their children through their life savings, and holds on to her unwavering conviction that he somehow came to harm. Neither wife nor widow, Marcie faces a crossroads when a new love enters her life. The book is available in both print and Kindle editions on amazon.com and in any e-reader format on smashwords.com.

Bruney's first book, a work of nonfiction, was published in 2003. "I'd Rather Go to California" was followed by "Angels Unaware," "The Almost Bride," and "The Lunch Club," all contemporary women's fiction titles. "Riverbend" is set in Anson County in the early 1800s. "A Question of Boundaries," "A Question of Loyalty," and "A Question of Time" are alternate history/paranormal stories that Bruney admits were great fun to write. They are available as both e-books and Audible.

Bruney also coauthored "Plotz," a thriller, with Elbert Marshall, formerly of Wadesboro, as written by Marshall Bruney.

Old Castle - Adams Products To Expand Lilesville Facility

Anson Economic Development Partnership announced that Old Castle - Adams Products Division is expanding its facility near Lilesville. The company plans to invest up to \$2.3 million over the next 3 years in physical expansion of the plant and the addition of new equipment. The project is expected to generate at least 10 new jobs.

Old Castle currently operates a 100,000 square foot ready-mix bagged concrete facility which employs 69 at the site off Haileys Ferry Road. Products produced at the plant are shipped throughout the Carolinas to hardware stores, big box retail and construction contractors, with 75% of production going to Lowe's and Home Depot. The new buildings, equipment and jobs are in response to increased demand from the retail sector and the trend toward DIY construction projects, and will be phased in at the location over a 2-3 year period, beginning with a new half-million dollar warehouse expansion that broke ground recently.

Plant manager Kevin Tucker says the new jobs are mostly entry-level, but pay a good wage and are a great starting point for young, dedicated workers. "I understand our jobs are not for everyone. They require a fair amount of physical strength and stamina, and the working conditions can be challenging, but we start unskilled workers at a rate significantly above fast food and retail, and offer them a legitimate path to a good quality of life. Old Castle is a company where you can still come to work with nothing more than a high school diploma and, if you are willing to work hard and act responsibly, build your way up to a wage that will support a family."

The company uses Talent Force for its hiring and refers all potential applicants to them. According to AnsonEDP executive director John B. Marek, "One of the great things about Anson County is that we have good opportunities for manufacturing workers at a variety of different skill levels. Whether you're an experienced CNC machinist or a recent high school graduate with minimal work experience, there's a path to prosperity for you in Anson County."

CONSTITUTIONAL AMENDMENTS (REFERENDA)

- (Vote For or Against)
- **Constitutional amendment** protecting the right of the people to hunt, fish, and harvest wildlife
- **Constitutional amendment** to strengthen protections for victims of crime; to establish certain absolute basic rights for victims; and to ensure the enforcement of these rights.
- **Constitutional amendment** to reduce the income tax rate in North Carolina to a maximum allowable rate of seven percent (7%).
- **Constitutional amendment** to require voters to provide photo identification before voting in person.
- **Constitutional amendment** to change the process for filling judicial vacancies that occur between judicial elections from a process in which the Governor has sole appointment power to a process in which the people of the State nominate individuals to fill vacancies by way of a commission comprised of appointees made by the judicial, executive, and legislative branches charged with making recommendations to the legislature as to which nominees are deemed qualified; then the legislature will recommend at least two nominees to the Governor via legislative action not subject to gubernatorial veto; and the Governor will appoint judges from among these nominees.
- **Constitutional amendment** to establish an eight-member Bipartisan Board of Ethics and Elections Enforcement in the Constitution to administer ethics and elections law.
